

RIDE & SHARE BIKE WEEK COMPETITION 2024: FULL TERMS & CONDITIONS

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications. Participants should retain a copy for their information.

1. The Promoter: Pluxee U.K Limited, Enigma, The Park MK, Ortensia Drive, Wavendon, Milton Keynes, MK17 8LX UK.
2. Eligibility: The Ride & Share Bike Week Competition 2024 is only open to employees of any company that holds an active contract for a Cycle Benefit Scheme managed via The Promoter. Participants must complete all steps outlined in the competition details during the Promotion Period. Employees of the Promoter, their families, agents, and anyone professionally connected with the competition are not eligible to participate.
3. Promotion Period: The Ride & Share Bike Week Competition opens to entries at 00:00 GMT on 10th June 2024 and closes at 23:59 GMT on 30th June 2024.
4. Competition Entry:
 1. Follow us on the platform you'll post on - Facebook, Instagram, LinkedIn, or TikTok.
 2. Safely capture your favourite cycling moments & post them, adding #RideWithPluxee to the caption.
 3. Tag Pluxee UK in your post for a bonus entry.
5. Prize Draw: All participants who complete the competition steps during the Promotion Period will qualify for the Prize Draw to win one of five £100 eVouchers for the retailer of their choice.
6. Prize Draw Winner Selection: Five winners will be selected at random under independent supervision within 15 working days of the end of the Promotion Period.
7. Prize Draw Winner Notification: All winners will be notified by the social media platform used for their entry within 5 working days of Prize Draw Winner Selection. The Promoter has the right to validate all prize claims and reject any claims not meeting all the terms and conditions as set out.
